CONDITIONS, WAIVER & RELEASE

CONDITIONS, WAIVER AND RELEASE

I fully understand, acknowledge and agree that the Club will only permit me to become a member, enter its lands and buildings (the "Property") and use its Club Facilities including, but not limited to, the café, lounge, pool and café decks, carpark, golf course, golf driving range, swimming pool and gymnasium (the "Club Facilities") on the basis of this certification that I freely make herein.

I hereby certify that I:

1. whenever I use the Club Facilities, I will be physically fit, not impaired by drugs or alcohol, and capable of using the Club Facilities without injury or danger to myself or others and at all times ;
2. will abide by the Club rules, by laws and policies as determined and amended from time to time by the Club board and will at all times obey all instructions from Club officials;
3. will provide proof of my identity on demand and permit that proof to be copied and confidentially stored by Club officials;
4. may be held personally responsible and liable for any damage I cause to any person or property resulting from my use of the Club Facilities;
5. permit the Club to record and store images of me on its CCTV system and disclose that imagery to Club officials and advisors, law enforcement authorities and legal representatives if authorised by the Club board;
6. specifically acknowledge the Club Facilities are generally un supervised by Club officials (and in particular the swimming pool, swimming decks and gymnasium are NOT PATROLLED BY GUARDS) and I am therefore using the Club Facilities voluntarily, entirely at my own risk and with full comprehension of my responsibility not to endanger any other person or property;
7. will never use the swimming pool, pool decks or gymnasium if I am under the age of 16 unless I am accompanied and supervised directly by an adult member.

I hereby waive, release and discharge any and all claims for damage for personal injury, death or property damage which I may have, or which may hereafter accrue to me as a result. This release is intended to discharge in advance the Club, Sanctuary Living Investments Pty Ltd, Streadland Pty Ltd, and each of its officers, employees and agents (collectively referred to as the "Parties") from any and all liability arising out of or connected in any way with my use of the Club Facilities even though that liability may arise out of negligence or carelessness on the part of the Parties. It is understood that use of the Club Facilities involves the risk and danger of accidents and knowing those risks, I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns.

I agree to indemnify and to hold harmless, the Parties, from any loss, liability, damage, cost or expense which they may incur as the result of my death or any injury or property damage that I may sustain or cause to be sustained by others while using the Club Facilities. I understand that by entering Club property and/or using the Club Facilities I consent to photo or video images taken by the Parties may be used in any enforcement proceedings against me or the Club or in Club publications and websites. I further understand that the Parties may use my contact details to inform me of upcoming Club events and offers however my contact details will not be disclosed to anyone else other than law enforcement authorities or government officials as determined by the Club board.
